– Explanatory Note:

Nexia Edwards Marshall have acted as Auditors for the SMSF Association for the past 6 financial years and there has not been any disagreement with Nexia Edwards Marshall at either the Board or management level in relation to the conduct of the Audit. The Association has been pleased with the service level that they have received during their tenure.

It was determined by the Finance, Risk and Audit Committee in accordance with sound corporate governance principles to seek requests for tender for the 2024 Financial Year. The Finance, Risk and Audit Committee received tenders from four audit firms to provide independent external audit services to the company.

The Finance, Risk and Audit Committee and Board recommend the appointment of William Buck, as the Association's incoming Auditor.

A Notice of Intention was provided to Nexia Edwards Marshall.

William Buck have provided their consent to be appointed as auditor.

Michael Houlihan, a member of the SMSF Association, has nominated William Buck who are eligible and in accordance with Section 328B(1) of the Corporations Act 2001.
